Stone, Aurangabad –Paithan Road, Village Chittegaon, Tal.: Paithan, Dist.: Aurangabad - 431 105 at 2.00 p.m. to transact the business as mentioned in the Notice of AGM dated 14th May, 2015.

- I, Subhash S. Dayama, Chairman appointed for Annual General Meeting refer to the Scrutinizers Report and would like to inform you as under:
- The Company on Saturday, 6th June, 2015 completed the dispatch of Annual Reports along with Notice of AGM to all shareholders of the Company and all other persons who are entitled to receive the same through permitted mode. The Company fixed Tuesday, 23rd June, 2015, as the cut-off date/entitlement date for identifying the Shareholders entitled to participate for e-voting process (remote e-voting) and voting by Ballot at AGM.
- The remote e-voting facility remained opened from Saturday, 27th June, 2015 at 9.00 a.m. to Monday, 29th June, 2015 till 5.00 p.m., both days inclusive. The remote e-voting facility was not allowed beyond 5.00 p.m. on Monday, 29th June, 2015.
- Mrs. Kanchan A. Kakade, Company Secretary in Whole Time Practice, (CP No.:11999)
 was appointed as a Scrutinizer for conducting the voting by Ballot at the AGM and
 remote e-voting process in a fair and transparent manner.
